Directions
Take 89 north from McKee for 3 miles. Turn right on Macedonia Road for .5 mile. Turn left on Turkey Foot Road for 1 mile. The road turns to gravel, Forest Road #4. Stay on this for 1.9 miles. Turn left onto Forest Road 345 and follow signs to the campground



Open Dates
Trails are open all year; camp is closed during the winter.



Trail Fees
None.



Restrooms
Vault toilets at campground; toilets open year round.



Parking
At campground. When camp is closed, park outside gate. Do not block gate.



Accessibility
These trails do not meet accessibility standards for persons with disabilities.



Trail is closed to motorized vehicles.



Consumption of alcohol and open containers of alcohol are prohibited.



No camping or firebuilding in rock shelters.

These trails are located in Turkey Foot Campground on London Ranger District, nestled along the banks of War Fork Creek. The creek is stocked with trout. The gravelled road into the campground is quite steep. There is a low water ford across the creek at the campground entrance. Do not attempt to drive across if it is flooded. The Sheltoewe Trace National Recreation Trail is accessible from the campground. The trail west from the campground is open to off-highway vehicles less than 50" wide.

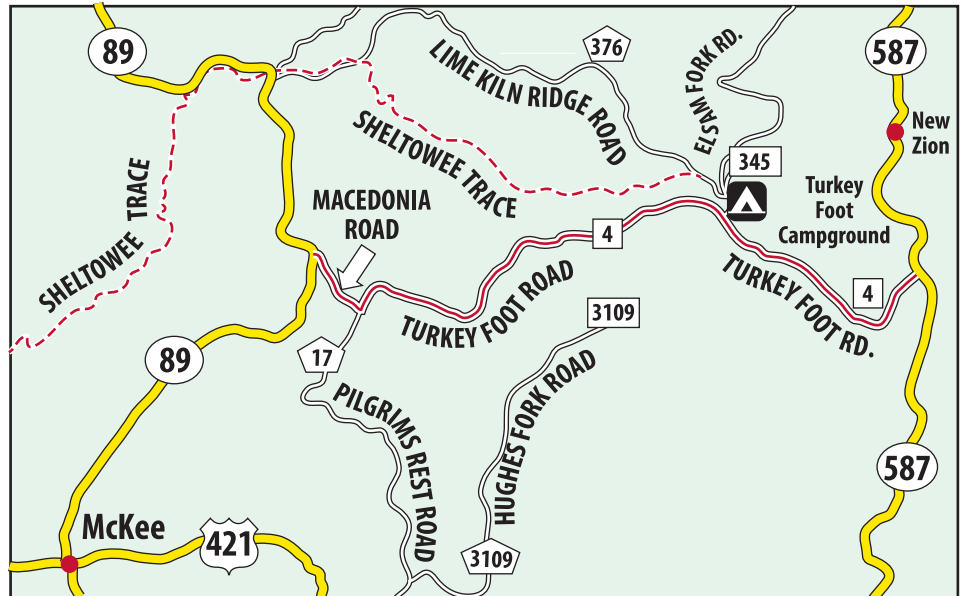

CAUTION: Low lying areas are prone to flooding, so be alert for flooding when driving, camping or crossing streams in this area. Swift currents and undertows can make swimming and wading very hazardous.

FOOD STORAGE REQUIRED. Visitors in developed sites must store food, garbage and other odorous items that may attract bears in a bear-resistant container, inside their vehicle, or in an enclosed hard-body trailer. Backcountry campers must suspend food, garbage and odorous items at least 10 feet off the ground and four feet away from any tree or pole. All food leftovers and trash must be properly disposed of in a bear-resistant trash receptacle or other container where provided by the Forest Service.
